

FREQUENTLY ASKED QUESTIONS

WHAT IS A PICK 'EM CARD?

A Pick 'Em Card is a season-long contest in which participants pick the winners of the Sunday and early Monday night games each week, attempting to have the best record each week and the entire season to win prizes—up to \$1,000,000 cash for a season-long record of 225 or more winning picks.

Pick 'Em Cards are filled out and submitted online each week of the regular NFL season, Tuesday – Saturday.

HOW TO ACTIVATE PICK 'EM CARDS

You must activate your Pick 'Em Cards to be eligible to win leaderboard prizes each week. Activate your picks by swiping your Rio Rewards at any Rio Rewards kiosk once, each Tuesday – Sunday. To be eligible to win the overall season long leaderboard prizes, you must have activated your weekly picks at least once during the regular season.

WHAT CAN I WIN?

Pro Football Frenzy includes a \$1,000,000 Cash Prize for 225 or more correct picks throughout the regular season, and \$20,000 in guaranteed Weekly and Season-long Leaderboard Prizes.

HOW DO I CLAIM LEADERBOARD PRIZES?

Leaderboards are updated online every Tuesday, September 10 though December 31, 2024, and Monday, January 6, 2025, on the program website. Prizes are loaded to the winner's Rio Rewards card. Winners will be notified via an email on file at The Rio when the FrioPlay is available on winners Rio Rewards card each week. All FrioPlay Prizes will expire 7 days from issuance.

OFFICIAL RULES

- 5. Million Dollar Pro Football Pick 'Em Cards **must be activated** by swiping a Rio Rewards card at any Rio Rewards kiosk at least once during the season to be eligible to win the \$1,000,000 cash prize or a Season-long Leaderboard prize.

- 12. Winners' prizes will be loaded to their Rio Rewards card.
- 13. All FrioPlay prizes related to this promotion will expire 7 days from issuance. Prizes not used within seven (7) days will be forfeited and not reissued.

In the case of a Weekly Leaderboard tie, the participant whose tiebreaker Total Score for the early Monday Night Football game (or other designated game), is closest without going over will win. If there is still a tie, the time the entry was submitted online is the tiebreaker. The earliest submitted entry will be the winner. If an additional tiebreaker is needed, a random drawing will be held across all tied participants.
- 15. In the case of a Season Long Leaderboard tie, the participant who submitted their first Pick 'Em Card of the season earliest will be the winner. If there is still a tie for the total season long prizes, a random drawing will be held across all tied participants.
